**Spoštovani gospod António GUTERRES,
spoštovani člani Združenih narodov,**

Z izjemnim spoštovanjem se obračam na vas v imenu Društva za srečno življenje BELIS glede Zakona o izstopu iz vaše spoštovane organizacije, Organizacije združenih narodov. Prepoznavajoč pomen Združenih narodov pri uresničevanju mednarodnega miru, varnosti in razvoja, želim pritegniti vašo pozornost k vprašanju, ki zadeva suverenost.

S to diplomatsko noto vas obveščam, da je Društvo za srečno življenje BELIS (Društvo BELIS) na izrednem občnem zboru, ki je potekal 15. julija 2023 v Ljubljani, Slovenija, sprejelo 'Zakon o izstopu iz ZN in SZO' (glej: Priloga 1). Ta zakon prav tako vključuje izstop iz Svetovne zdravstvene organizacije (SZO) ter Akta o izstopu iz uredb Evropske unije (EU), povezanih z vašo organizacijo, ZN. Kot pravna entiteta v Republiki Sloveniji Društvo BELIS s tem Zakonom o izstopu iz ZN in SZO ureja pravni status uradnega izstopa iz teh mednarodnih organizacij in preneha biti njihova članica z dnem 15. julija 2023.

Ta odločitev je bila sprejeta na 6. izrednem občnem zboru Društva BELIS z več kot dvotretjinsko večino glasov, kjer so člani društva odločili o izstopu in prekinitvi sporazumov, ki jih je Društvo BELIS kot pridružena članica Republike Slovenije imelo z Združenimi narodi in Svetovno zdravstveno organizacijo. V skladu z mednarodnim pravom, ustrezno pravno podlago in na osnovi suverenosti države ter pravic domorodnih ljudstev, ki jih varuje Ustava Republike Slovenije, ki jih prav tako ščiti Mednarodni pakt o državljanskih in političnih pravicah (sprejet 16. decembra 1966, resolucija št. 2200), Društvo za srečno življenje BELIS, kot zasebna pravna entiteta, uveljavlja svojo pravico do samoodločbe in pravico do izstopa iz mednarodnih organizacij, ki ne več služijo uresničevanju ciljev in namenov, kot so zapisani v ustanovni listini društva.

Društvo BELIS je bilo posredno prizadeto z Akti o nasledstvu Komisije za mednarodno pravo Združenih narodov in mednarodnih pogodb, ki zadevajo Republiko Slovenijo. Vendar pa je društvo sprejelo odločitev, da zavrne nasledstvo po teh aktih, saj trenutno nasprotujejo njegovim temeljnim načelom in ciljem, kar postavlja društvo v diametralno nasprotno položaj v odnosu do njegovih osnovnih vrednot.

Izrednega pomena za Društvo BELIS je, da se njegova odločitev o izstopu spoštuje in da se prekinejo vse obveznosti, ki izhajajo iz njegovega članstva v Združenih narodih in Svetovni zdravstveni organizaciji v imenu Republike Slovenije in s tem tudi Društva za srečno življenje BELIS. Izstop Društva BELIS ne posega v pravice in obveznosti Republike Slovenije kot članice Združenih narodov in Svetovne zdravstvene organizacije. V luči tega dejstva izražamo tudi našo aktivno pripravljenost za sodelovanje z drugimi članicami Združenih narodov pri izvajanju predlagane rešitve izstopa. Vzpostavljanje medsebojnega sodelovanja, izmenjava informacij in usklajevanje prizadevanj za doseg skupnih ciljev so ključnega pomena za vzpostavitev miru in harmonije.

Z izvedbo te odločitve o izstopu iz vaše ugledne mednarodne organizacije bo Društvo BELIS lažje in z večjo zavzetostjo nadaljevalo svoje poslanstvo, s katerim si prizadeva za resnični mir v svetu, ki je v skladu z njegovimi vrednotami, filozofijo, etičnimi standardi in načeli.

Na osnovi navedenega predlagamo, da kot generalni sekretar Združenih narodov potrdite prejem te obvestilne note o izstopu Društva BELIS iz Združenih narodov in prenehanju njegovega članstva s pisno potrditvijo, ki jo boste nazaj poslali društvu. Hkrati vas vljudno prosimo, da obvestite vse države članice in podrejene organe ZN o sprejetju Zakona o izstopu iz ZN in SZO (Priloga 1), vključno s tistimi, ki zadevajo nacionalno zakonodajo Republike Slovenije.

Naj izrazimo našo iskreno zahvalo za vašo pozornost do te zadeve in pričakujemo, da boste našo odločitev ustrezno upoštevali ter izdali potrdilno noto o izstopu Društva za srečno življenje BELIS iz Organizacije združenih narodov, s čimer bomo nedvomno preprečili morebitne prihodnje spore ali nepotrebne konflikte.

**Esteemed Mr. António GUTERRES,
Respected Members of the United Nations,**

With profound deference, I address you on behalf of the Association for Happy Living BELIS regarding the Law on Withdrawal from your esteemed organization, the United Nations. Recognizing the significance of the United Nations in the pursuit of international peace, security, and development, I seek to draw your attention to a matter of sovereign concern.

Through this diplomatic communication, I hereby inform you that the Association for Happy Living BELIS (BELIS Association) adopted, on an extraordinary general assembly held on July 15, 2023, the 'Law on Withdrawal from the UN and the WHO' (see: Annex 1). This law also entails the exit from the World Health Organization (WHO) and the Act on Withdrawal from European Union (EU) regulations associated with your organization, the UN. As a legal entity in the Republic of Slovenia, the BELIS Association, through the aforementioned Law on Withdrawal from the UN and the WHO, regulates the legal status of official withdrawal from these international organizations and ceases to be their member as of July 15, 2023.

This decision was reached during the 6th extraordinary general assembly of the BELIS Association held on July 15, 2023, in Ljubljana, Slovenia. With more than a two-thirds majority of votes, the members of the association resolved to exit and terminate the agreements that the BELIS Association, as an affiliate of the Republic of Slovenia, had with the United Nations and the World Health Organization. In accordance with international law, relevant legal considerations, and based on the sovereignty of the state and the indigenous rights enshrined in the Constitution of the Republic of Slovenia, which are also protected by the International Covenant on Civil and Political Rights (adopted on December 16, 1966, resolution 2200), the BELIS Association, as a private legal entity, exercises its self-determination and right to withdraw from international organizations that no longer serve the needs and objectives outlined in its charter.

The BELIS Association was indirectly affected by the Acts of Succession of the United Nations International Law Commission and international treaties related to the Republic of Slovenia. However, the association has chosen to reject the succession under these acts as they currently contradict its founding principles and objectives, placing it in a position diametrically opposed to its core values.

It is of utmost importance to the BELIS Association that its decision to withdraw is respected, and all obligations stemming from its membership in the United Nations and the World Health Organization on behalf of the Republic of Slovenia and consequently, the Association for Happy Living BELIS are terminated. The withdrawal of the BELIS Association in no way encroaches upon the rights and obligations of the Republic of Slovenia as a member of the United Nations and the World Health Organization. In light of this fact, we express our active willingness to collaborate with other United Nations members in implementing the proposed withdrawal resolution. Mutual cooperation, information exchange, and alignment of efforts to achieve common goals are imperative for the establishment of peace and harmony.

By enacting this withdrawal measure from your esteemed international organization, the BELIS Association shall be able to continue its mission with greater ease and conviction, striving to contribute to genuine world peace in accordance with its values, philosophy, and ethical standards and principles.

Based on the aforementioned, we propose that as the Secretary-General of the United Nations, you acknowledge this notification of the BELIS Association's withdrawal and cessation of its membership in writing, providing an official note of acknowledgment to the association. Furthermore, we kindly request that you inform all member states and subsidiary bodies of the UN about the adoption of the Law on Withdrawal from the UN and the WHO (Annex 1), including those aspects relevant to national legislation within the Republic of Slovenia.

We extend our gratitude for your attention to this matter and anticipate that you will duly consider our decision, thereby issuing an affirmative note confirming the exit of the Association for Happy Living BELIS from the United Nations, thus avoiding any potential future disputes or unnecessary conflicts.
