S tem dopisom želimo sporočiti, da je naša organizacija, Društvo za srečno življenje BELIS, na svojem šestem izrednem Občnem zboru, ki je potekal na društveni 124. seji dne 15. 7. 2023, sprejela odločitev o *popolni zavrnitvi* Mednarodnih zdravstvenih predpisov IHR 2005. Naša odločitev temelji na pravnih razlogih, ki so navedeni v tem dopisu in v Prilogi 1, ter so skladni s členom 22 Ustave Svetovne zdravstvene organizacije in v povezavi s členom 59(1) Mednarodnih zdravstvenih predpisov IHR 2005.

Društvo za srečno življenje BELIS deluje kot samostojna pravna oseba zasebnega prava s svojimi lastnimi usmeritvami, cilji in delovanjem, kot je določeno v našem Statutu. V celoti si pridružujemo pravico do popolne zavrnitve *pravnih navodil* in drugih obvez iz Mednarodnih zdravstvenih predpisov (IHR) *ter pravico do izstopa* iz vaše organizacije Svetovna zdravstvena organizacija (SZO) in s tem tudi iz obveznosti IHR 2005 predpisov na način, ki je skladen s temeljnimi načeli našega Statuta.

Društvo za srečno življenje BELIS, s sedežem v Ljubljani, Republika Slovenija, ter z 5.252 člani iz 32 držav sveta, zahteva, da se ta dopis ustrezno evidentira in posreduje pristojnim organom Svetovne zdravstvene organizacije. Pričakujemo ustrezno obravnavo in odziv našega izstopa iz Svetovne zdravstvene organizacije (WHO) in iz Mednarodnih zdravstvenih predpisov (IHR). Prav tako pričakujemo, da se naše pridržke, ugotovitve in razloge za izstop upošteva ter se skladno odrazi v ustreznih dokumentih in komunikaciji med Svetovno zdravstveno organizacijo, Evropsko unijo, Republiko Slovenijo in našim Društvom.

Dear Director-General,

By means of this correspondence, we wish to convey that our organization, the Association for Happy Living BELIS, at its sixth extraordinary General Assembly held during the 124th session on July 15, 2023, has made the decision of *complete rejection* of the International Health Regulations (IHR) 2005. Our decision is grounded in legal justifications stated in this communication and Annex 1, and is consistent with Article 22 of the Constitution of the World Health Organization, in conjunction with Article 59(1) of the International Health Regulations (IHR) 2005.

The Association for Happy Living BELIS operates as an independent legal entity of private law, with its own orientations, objectives, and activities, as defined in our Statute. We unequivocally reserve the right to fully reject the *legal instructions* and other obligations stemming from the International Health Regulations (IHR), as well as the *right to withdraw* from your organization, the World Health Organization (WHO), and thus from the commitments under the IHR 2005, in a manner consistent with the fundamental principles of our Statute.

With its headquarters situated in Ljubljana, Republic of Slovenia, and comprising 5,252 members from 32 countries worldwide, the Association for Happy Living BELIS demands that this correspondence be appropriately recorded and forwarded to the competent bodies of the World Health Organization. We expect a proper handling and response to our withdrawal from the World Health Organization (WHO) and the International Health Regulations (IHR). Furthermore, we anticipate that our reservations, findings, and reasons for withdrawal will be duly taken into consideration and accurately reflected in relevant documents and communications between the World Health Organization, the European Union, the Republic of Slovenia, and our Association.

We eagerly await your official response regarding the coordination of our withdrawal from the WHO and the rejection of the International Health Regulations (IHR) 2005 with all amendments and supplements.
